Instructions for the Bidders

1. Bidders are requested to visit the <https://mahatenders.gov.in> and go through the “e-tendering Tool Kit” wherein the all basic Know how (detailed help documents designed for bidders) of the e-tendering stages are given.
2. Login ID and password to be created on the above website.
3. Class II or class III Digital signature (e-token) with signing, verification, and encryption and decryption certificate is essential. Bidders may purchase this from any reliable sources. The bidders are required to sign the bid data using above Class II or Class III digital signature as per the Information Technology Act, 2000. The digital signatory should be the authorized representative of the organization/bidder.
4. Tender form fee Rs.1,100/- (Rs. One Thousand One Hundred only) is to be paid online for the downloading of tender form and bid preparation. Earnest Money Deposit (EMD) Rs.25,100/- (Rs. Twenty Five Thousand One Hundred Only) is to be paid online by net banking.
5. The various activities /stages of e-tendering procedure for the bidders as well as for MAIDC are; date & time locked. Hence, bidders are requested to execute all the activities related to tender downloading, bid preparation & bid submission strictly as per the tender schedule (key dates).
6. This tender is strictly online tender. No manual bids will be accepted by MAIDC.
7. The rates /bid offers should be valid for 120 days. Right to be accept or reject any or all tenders in part or full without assigning any reasons thereof are reserved with MAIDC.

ANNEXURE – II

Terms & conditions for disposal of old vehicles of MAIDC Ltd.

1. Offer should be submitted only in the prescribed form available at our Website.
2. Rate should be quoted in words as well as in figures for individual vehicle
3. In case of any variation in rate in figures & words, the Corporation shall be at liberty to accept the rate/s, whichever is higher.
4. After acceptance of offer by the Corporation, whose offer has been accepted, fails to pay the full amount within seven days from the date of intimation to him it will be presumed that the offerer is not interested in purchase of vehicles & decision will be taken in the matter without making any further reference to such offerer & his Earnest Money Deposit will be forfeited.
5. Full amount of the rate accepted will have to be paid in advance on receipt of our letter.
6. Earnest money deposit will be refunded after completion of sale procedure of all vehicles.
7. Applicable GST on the sold vehicle will be recovered from purchaser.
8. The Corporation reserves the right to accept or reject any or all offers without assigning any reason thereof. Similarly the authority of acceptance of these tender vests with the Managing Director of this Corporation, who will hold power to reject lower price than anticipated without assigning any reason for the rejection.
9. Interest free Earnest Money Deposit of Rs. 25,100/- (Rupees Twenty Five Thousand One Hundred Only.) for all vehicles, is to be paid online payment, highest will be refunded as soon as the final decision on disposal of vehicle is taken. Earnest Money Deposit of the successful buyer will be refunded only on transfer of ownership of the vehicle in the name of the buyer & presentation of the proof by the buyer. E.M.D. of remaining two offers (Second & third) shall be refunded after receipt of amount from the highest bidder. EMD of unsuccessful Bidders will be refunded online after completion sale procedure of all vehicles.

10. Corporation has paid RTO tax for 15 years as per the RTO Rules. Accordingly, balance unused proportionate RTO Tax (If vehicle sold before use of 15 years) will be recovered from purchaser in addition to the bid price offered by him.
11. The RTO Tax Rule for 15 years term is exempted for goods vehicle. RTO Tax of goods vehicle are paid on yearly basis.
12. Octroi &/or Green Tax, if payable on these vehicle shall be borne by the buyer.
13. In case of dispute arising out of breach of contract or non-lifting of vehicle or dispute of any kind of whatsoever nature, only court in Mumbai shall have jurisdiction to entertain & try such dispute of claim arising therefrom.
14. The Corporation shall not be liable for any claims for loss, damage or compensation whatsoever if the offerer fails to lift vehicles within 15 days from the date of intimation to him regarding acceptance of his rate.
15. In case of any dispute, the decision of the Managing Director of this Corporation will be final & binding upon the buyer.
