General Tender Terms & Conditions:

- 1. E.O.I Bids: -
- a) There shall be two bids, one is the Technical Bid and the second is the Commercial Bid.
- b) The eligibility of the bidder shall be verified by opening the Technical Bid.
- c) At the MAIDC's discretion, the Commercial Bids may be opened for technically qualified bidders only.

2. Pre-E.O.I Meeting: -

There shall be a pre-bid meeting on 13/06/2024 at 'Krushiudyog' Bhavan, Aarey Milk Colony, Goregaon (E) Mumbai 400065, at the head office of the MAIDC.

3. Bid Fee & Earnest Money Deposit:-

- a) The non-refundable cost of the E.O.I. bid form shall be Rs. 10000 /-(Rs. Ten thousand only) (including GST). The Bid fee shall be paid online.
- b) The bidder shall pay online an interest-free Earnest Money Deposit of Rs. 50000/- (Rs. Fifty thousand only).
- c) The earnest money of the unsuccessful bidder shall be refunded without any interest in due course of time after the completion of the RFP's entire procedure and Allotment of Contract (AoC).
- d) The MSMEs shall be exempted from payment of Bid fee .

4. Bidders disqualification: -

- a) Bidder shall be out rightly disqualified for Incomplete/ Non-submission of any of the documents referred to in the Technical Bid and the failure of the submitted sample (One or More).
- b) Incomplete technical and commercial bids shall also be liable for disqualification.

5. Agreement Signing: -

- a) The successful bidder shall have to sign and execute an agreement for Drone spray and survey service on non-judicial bond paper and register the agreement to the appropriate authorities. The registration fees shall be paid by the bidder only.
- b) The MAIDC and bidder commit each other for Drone spray survey service.
- c) The bidder and the MAIDC shall abide by the terms and conditions mentioned herein and the agreement to be signed with the successful bidder.

6. Security Deposit: -

- a) The successful bidder shale pay an interest free refundable security deposit of Rs. 50000/- (fifty thousand only) for FPO and Rs. 500000/-(Five lacs only) for other.
- b) through RTGS NEFT/D.D.

- c) The earnest money can be adjusted into the security deposit of a successful Bidder.
- d) The security deposit shall be refunded without any interest in due course of time after satisfactory completion of contract.

7. Operation & Process : -

- a) MAIDC shall select area wise minimum two successful bidder from this E.O.I process. The Area may be grossly described as vidharbh, marathwada, Western-Maharashtra, North Maharashtra and Kokan region.
- b) The serviceable area for each successful bidder not more then 200 to 300 km peripheral
- c) For drone service the MAIDC shall indentify the interested farmer and to give the suitable service order to the nearest service provider
- d) The MAIDC shall not share any consumable costs, or operating costs at any stage of Drone service.
- e) During service of Drone spraying, Pilot and other crew member should have pre defined dress code and the dress code design will be approved by MAIDC officials.
- f) During service of Drone spraying the flying norms of D.G.C.A should be followed
- g) The bidder and the MAIDC shall jointly put their best efforts to increase awareness of Drone service within the farmers of Maharashtra

8. Payment Clause :-

- a) MAIDC shall pay within 30 days to the bidder from the date of service invoice along with the necessary documents.
- b) Bidder should submitted the taxable Invoice along with form A. B. and C. attached herewith as a tender document after completion of successful of Drone service for each service order.

9. Statutory Liabilities: -

- a) All statutory payments of workers are likely to be engaged by the bidder for Drone service like Provident Fund, Minimum Wages, E.S.I.C. and other compliance under labor laws shall be paid without any default or demur by the bidder only.
- b) The liability under the Workman Compensation Act about the employees engaged by the bidder during the period of agreement shall be entirely of the bidder in all respects.
- c) That the contract and license agreement shall and does not create any employer-employee relationship between the parties nor the MAIDC shall be construed as Principal Employer in any manner whatsoever.

10. Entries and Discipline of Employees Engaged by Bidder: -

- a) All the Officers/employees engaged by the bidder during the period of the agreement shall be required to submit valid identity proofs if required by the MAIDC.
- b) All Officers/employees likely to be engaged by the bidder during the period of the agreement, shall not be /will not be involved in any intoxicant, immoral, unethical, illegal, or criminal activities.

11. Confidentiality: -

- a) The bidder shall not disclose any such any matter to any third party or for its business practices or otherwise and shall be bound to keep as "classified and confidential" among bidder and the MAIDC.
- b) The bidder shall not indulge in any unfair trade practices in the marketing and sales jurisdiction of The MAIDC that are detrimental to the interest of the MAIDC.
- c) The bidder must adhere to and follow legal metrology for drone service as per guide line given by Department of Agriculture and Farmers welfare ministry and DGCA.
- d) The bidder shall be bound to follow the directions/orders issued by Govt. from time to time, regarding the use of Drone and Drone operations.

12. The Bidder covenants with The MAIDC as under: -

- a) That the successful bidder has to register at MAIDC Mahaagro Mart Online E- Commerce App as a service provider.
- b) The bidder shall not be permitted to enter into a third-party agreement at any time during the term of contract agreement regarding Drone service without the written permission of the MAIDC.

13. The MAIDC does with this covenant with the Bidder as follows:-

a) The bidder in its discretion may appoint the personnel/laborers but only by abiding by the laws applicable from time to time.

14. Insurance Payments: -

Insurance Payment as applicable from time to time for Drone and Drone service and other necessary nature like third party insurance shall be born and paid by the bidder.

15. Dispute Resolution: -

- a) Any dispute, difference, or controversy of whatsoever nature howsoever arising under or out of or about this agreement (including its interpretation) between the parties and so notified in writing by either party to the other party (the "Dispute"), shall in the first instance be attempted to be resolved by the conciliation procedure.
- b) The parties agree to use their best efforts to resolve all Disputes arising under or in respect of the contract agreement and drone operations promptly equitably.

16. Arbitration: -

a) Any Dispute that is not resolved amicably by mutual discussion shall be finally decided by reference to Arbitration by appointment of a mutually agreed arbitrator

b) Arbitration shall be conducted as per the Indian Arbitration and Conciliation Act, 1996.

- c) The venue of Arbitration shall be at Mumbai.
- d) The language of Arbitration Proceedings shall be English.
- e) The Arbitrator shall make a reasoned award (the "Award").
- f) Any Award made in any Arbitration held according to clause 2.1 shall be final and binding on both the parties and the parties undertake to implement such Award without delay.
- g) The agreement and the rights and obligations of the parties shall remain in full force and effect, pending the Award in any Arbitration proceedings hereunder.

16. Force Majeure: -

The Bidder and The MAIDC shall not be liable for any financial loss, damage, injury, or delay due to any cause beyond its control including (without prejudice to the generality of the foregoing expression) any act of war, external aggression, terrorism, vandalism, riot, civil commotion, sabotage, fire, flood, explosion, earthquake, pandemic, epidemic, quarantine restriction, or Other acts of God and Government (Force Majeure event).

17. Termination:- The MAIDC may terminate contract Agreement if-

- a) Bidder enters into contract with any other for Drone service in Maharashtra.
- b) Bidder fails to perform the service order of MAIDC.
- c) No party shall abruptly terminated the contract agreement within consent of either party

18. Applicable Laws & Court Jurisdiction:-

- a) The operations shall in all respects be governed by and construed following the laws in force in India.
- b) The Courts at Mumbai shall alone and exclusively have jurisdiction over the matter arising out of the leave and license operations.

19. Stamp Duty & Registration: -
